Mid-career professionals and managers working in science and technology fields or those with roles or experience in these areas.

FORMAT/LENGTH

24 months part-time, Monday & Wednesday evenings, plus a 3 (full) day intensive each semester, September start

APPLICATION DEADLINES

- Round 2: March 16, 2018
- Final Round: June 1, 2018

ADMISSION REQUIREMENTS

- Undergraduate degree: min CGPA of 3.0
- Work experience: 4 years or more, preferably in tech or biotech industries
- Min GMAT: 550
- Proficiency in English for ESL candidates: TOEFL 93+ or IELTS 7+

This program provides a dynamic exchange of ideas with faculty who are thought leaders in their fields and classmates who are experienced in different industries and functional areas.

Mid to senior level managers who seek to develop the business acumen and enhanced capacity for the critical, innovative and strategic thinking required for success at the senior management level.

FORMAT/LENGTH

20 months part-time, Friday & Saturday, alternate weekends, September start

APPLICATION DEADLINES

- Round 1: January 12, 2018
- Round 2: March 16, 2018
- Final Round: June 15, 2018

ADMISSION REQUIREMENTS

- Business experience: minimum 10 years overall and 4 in management
- An undergraduate degree: min 3.0 CGPA. Exceptional managers who lack a formal degree or professional designation and do not meet this requirement, but have strong leadership experience may be considered. The average amount of experience is 18 years with 10 or more years of management experience.
- Proficiency in English for ESL candidates: TOEFL 93+ or IELTS 7+

TUITION & FEES

- Tuition: \$55,000*
- Includes all course materials, off-site orientation and workshops.

Students who take the optional Americas MBA for Executives during Year 2 can expect additional costs for transportation, food and accommodation when visiting the partnering schools (approx. \$8,000).

EMBA ABL

EXECUTIVE MASTER OF BUSINESS ADMINISTRATION
IN ABORIGINAL BUSINESS & LEADERSHIP

The Executive MBA in Aboriginal Business and Leadership explores the issues involved in building Aboriginal business, in the interactions between industry and Indigenous communities, in the development of Aboriginal organizations and in the ways non-Aboriginal organizations interact with Indigenous peoples. The program strives to include perspectives informed by traditional knowledge and worldviews with knowledge from western traditions and the social sciences in order to provide a sound basis for decision making in the context of management and leadership.

IDEALLY SUITED FOR

Individuals who are interested in Nation-building and have experience running a successful business, implementing economic development strategies, working as a senior administrator for a band council government, or in another relevant area.

FORMAT/LENGTH

25 months with intensive in-class components for an average of 30-35 days per year, September start

APPLICATION DEADLINES

- Round 1: December 15, 2017
- Round 2: February 15, 2018
- Final Round: April 15, 2018

ADMISSION REQUIREMENTS

- Business experience: Five to ten years of work experience, with at least four of those years in a managerial or professional position.
- Academic achievements: An undergrad degree in any discipline. A two-year diploma and outstanding grades will be considered. A limited number of people who lack a formal degree or professional designation, but have other outstanding qualifications may be admitted.

TUITION & FEES

- Tuition: \$55,500*
- Includes all course materials, off-site orientation and workshops.
- An additional cost of \$2,000 – \$4,000 will be folded into the SFU tuition for the study trip.

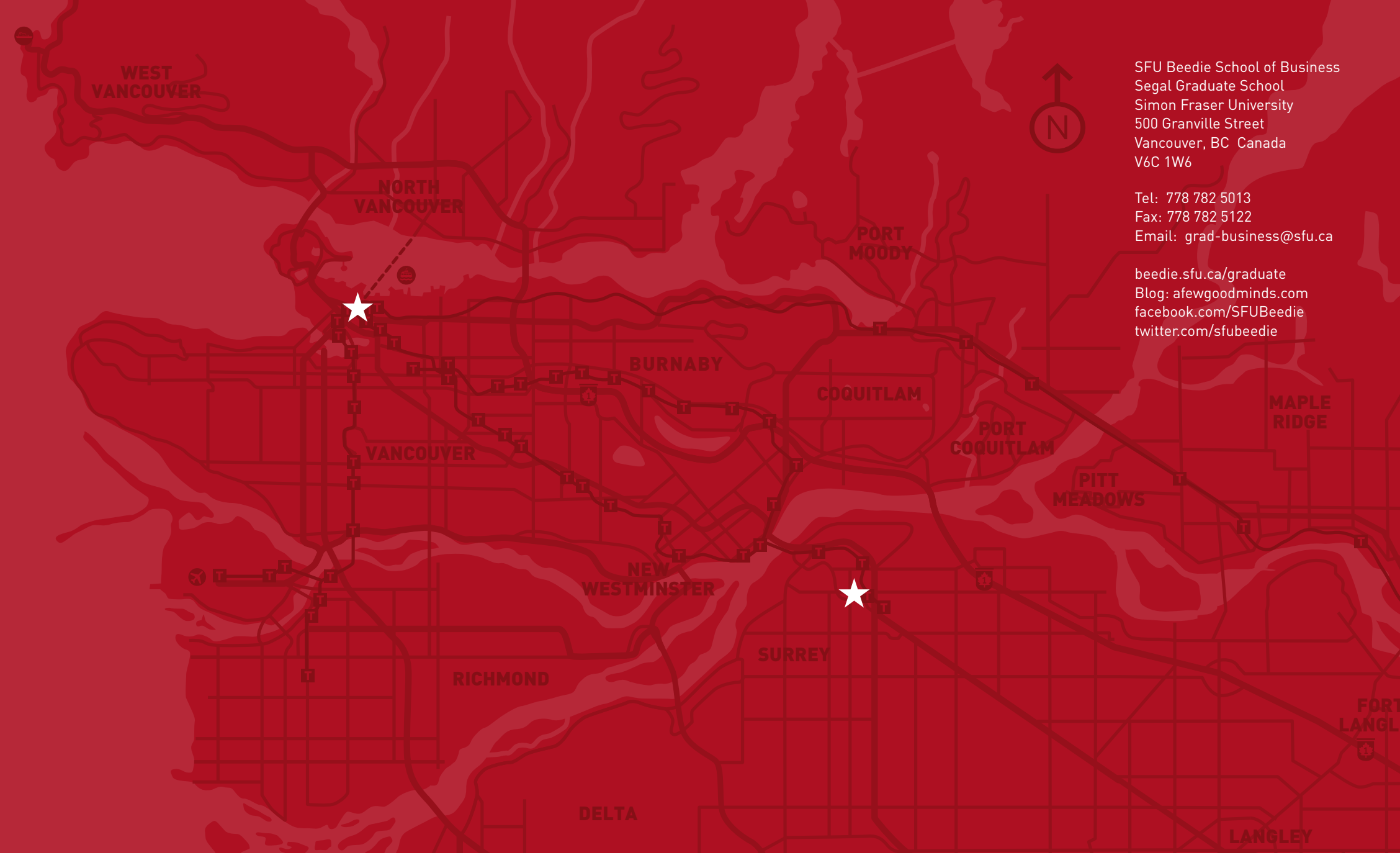
